

Engines:

Weavertown Diesel has a **3 YEAR WARRANTY** on its engines past the date of delivery.

Our #1 goal is to provide you with a Engine that will last way beyond the life of your truck. But everything is man made and prone to failure.

Most industry professionals agree that a correctly assembled engine that lasts 30 days will likely continue to do so for an extended period. The components used in our engines have met specific fitment, performance and functionality standards that we believe offer a perfect blend between quality and value. In the event that one of these components does not uphold these standards it may be subject to warranty.

Examples of Coverage

- Oil/Coolant Leak of components of the pre-assembled long block
- Incorrectly Assembled SubComponent or Component Group (Timing, Lash)
- New Products Subject to Manufacturer Warranty (Oil Cooler, Water and Oil Pump)

What IS NOT Covered

- Driver Abuse of Product or Neglect
- Installation Errors or Damage
- Incorrect Application Use
- Used or Customer Provided Parts
- Items with No Proof of Purchase
- Labor, Towing, Rental or Any Other Related Incurred Expenses (Unless Approved)
- Cracked Pistons, Bent Rods
- Failures as a result of Excessive RPM, Coolant Temperature or Oil Contamination
- Product Not Meeting Your Expectations vs Budget

SIDE NOTE: Mahle MotorSport Pistons are used in all of our builds (a major preventative Upgrade) and it would take very high Exhaust Gas Temperatures to be able to crack them. Which likely is a result of bad tuning, faulty injector or driver abuse.

NOTE: Many of the things listed above are preventable. Engine failures are often a secondary outcome to a root problem that must be corrected. Warranting an engine and not solving the root cause will not benefit either party.

Engine Warranty Process

Failures or suspected performance concerns must be reported to Weavertown Diesel via email at weavertowndiesel@gmail.com

BEFORE any corrective work is performed. Please have your order number or proof of purchase accessible. Depending on the concern, pictures or video evidence may be required for claim investigation. This media must be sent to weavertowndiesel@gmail.com

In rare cases engines will need to be sent in for further examination prior to warranty consideration. The corrective process for any repair must be approved by *Weavertown Diesel*. A written and signed estimate will be required before approval. Reimbursements are paid directly to the entity providing service. In the event parts are deemed defective, *Weavertown Diesel* will provide a like kind replacement or reimbursement for the value of the part at the jobber price *RW Diesel* pays. Warranty labor will be paid based on published warranty book time at a rate of \$85/hr. Warranty does not mean unconditional replacement. Warranty coverage comes in many forms and may result in compromises being made by both parties.

Our goal is to provide the consumer a professional solution in a timely manner. This warranty statement is designed to be a guide. Any and all warranty decisions require personalized attention and may not fall subject to the literature above. Changes to this policy can occur at any time. All warranty decisions are final.
